*Note: DOC (7.06) oppose all of the subdivision rules, standards and matters of discretion as in their view they fail to recognise the quality of the environment, amenity values, and public open space and do not achieve SUB-O1, SUB-P2 and SUB-P6. None of the subdivision rules, standards or matters of discretion can therefore be treated as operative.*

*Note: DOC (7.09) oppose the earthworks rules and standards as the standards, matters of control, and matters of discretion collectively fail to manage silt and sediment loss. No rules or standards in the EW Chapter can therefore be treated as operative.*
